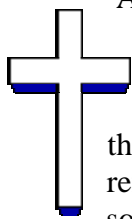

Chaplain's Message



As we begin the New Year, we continue with our third reflection of Catholic Social Teaching - right and responsibilities. The first and primary theme of Catholic Social Teaching is the dignity of the human person. In the second reflection, we noted that the human person is both social and sacred and that we realize our dignity in relationship to others, particularly in the family which is the basic unit of society.

This month we reflect on what we as persons have the right to expect from government and what is expected of us as individuals in society. Each of us has a fundamental right to life, food, shelter, health care, education and employment http://www.osjspm.org/major_themes.aspx. We not only have a right to these fundamental needs but must also respect that all people have these same rights. Basic rights and obligations are reciprocal. We cannot claim an individual right and then seek to deny others that same right. Christianity looks at both our individual needs and for the needs of all, since we are linked in a common bond.

The Knights, in various activities and programs, support each of the fundamental human rights, particularly the right to life for the unborn. The Knights stand with the Church in the right to life from conception to natural death. The Knights also support education. We are thankful that the Knights provide grants and scholarships to further the education of our youth and young adults. Education concerns not only public education but the education which takes place in the family. Pope Benedict XVI recently reminded us that the right to education extends to the parents' obligation to educate their children in the Catholic faith.

The continuing efforts of the Knights of Columbus reflect an organization which promotes the good of society and rewards individual achievement consistent with Catholic teaching. The Knights help those who do not have the resources or ability to help themselves with basic human needs. We are grateful for our ability to participate.

Perhaps in the New Year, we can consider some resolutions which help us in making sure we have a proper focus for our lives. We can consider spending more time in prayer, particularly as a family. Parents can start a family bible sharing in which each person can relate their experiences to a selected reading. We can consider volunteering at St. Margaret parish which provides a variety of opportunities to allow us to grow in faith and to see the results of our efforts. For those who are overactive and seem to be doing a lot of running around, our resolution may simply be to find more time to relax. It is important that we not overdue our good intentions. We should select a resolution that can affect a long term change in our lives not just something temporary that wears us out.

In 2008, we will be casting some very important votes. We might start our new year by reading the United States Council of Catholic Bishops document entitled "Faithful Citizenship" which addresses the seven themes of Catholic Social Teaching and teaches about having a properly formed conscience prior to voting.

Remember "Happy New Year" is a pro-life statement.

May the Lord continue to bless our small daily sacrifices and acts of charity.

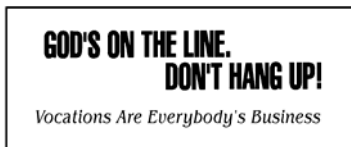
